<sup>&</sup>lt;sup>6</sup> No prior registration is required to use the business application. As part of the business application the Hungarian Post provides the service of itemization of the fees to be paid as the result of the customs clearance; payment of the fees by bank card and downloading relevant electronic invoices, customs clearance certificates and customs assessments.

<sup>7</sup> The use of the business application requires the conclusion of a separate written contract with Magyar Posta. The application may be used by natural persons designated by the organisation and authorised to do so by the organisation. Users with requested authorisation will only be able to fully use the application's functions after their authorisation has been entered in the settings.
